Whereas the **Mediciti Institute of Medical Sciences, Ghanpur**, affiliated to Kaloji Narayana Rao University of Health Science, Nizampura, Warangal has submitted Annual Disclosure Reports for year 2023 & 2024 for the Annual Renewal of Recognition as mandated by "Maintenance of Standards of Medical Education Regulations, 2023"(MSMER-2023).

2. Whereas, the Annual Disclosure Reports 2023 & 2024 of Mediciti Institute of Medical Sciences, Ghanpur is under scrutiny and **since the NEET PG counseling of the year 2025 is underway, the college is hereby granted Conditional Renewal of the following 17 courses as under and subject to the scrutiny of ADRs**, necessary action will be taken as per the regulation for the under-mentioned courses:

3. Whereas, based on your application for recognition/renewal of recognition in the year 2022, the following PG seats were reduced by PGMEB owing to following deficiencies:-

S. No.	Course name	Seats reduced	Deficiencies
1.	MS-Ophthalmology	04 to 03	(i) Deficiency of one Associate Professor and one Senior Resident as per the Report of the Aadhaar Enabled Biometric Attendance System (AEBAS); and (ii) Inadequate beds in the Department for the four PG seats
2.	MD-Respiratory Medicine	06 to 04	(i) Deficiency of one Professor, three Associate Professors, one Assistant Professor and two Senior Residents in the Department as per the Report of the Aadhaar Enabled Biometric Attendance System (AEBAS) report; (ii) Thirty beds were available in the Department and all were under renovation (iii) Beds placed close to each other, and there was no airborne infection control measure (iv) No segregation of TB beds and non-TB beds (v) No NTEP call is available in the Department (vi) Drug-Resistant TB beds were not available (vii) No faculty rooms were provided (viii) Overall cases load in OPD and IPD inadequate; and (ix) Pulmonary Function Test (PFT) and Bronchoscopy Tests were not adequate and needed improvement.

4. Whereas, subsequent to the reduction of seats, the college had submitted 1st Appeal to NMC vide its letter dated 29.06.2024 against the above decision of PGMEB. The 1st Appeal Committee agreed with the decision of PGMEB for reduction of seat.

5. Whereas, Mediciti Institute of Medical Sciences, Ghanpur has submitted the Annual Disclosure Report of the said course and now therefore PGMEB has reviewed its decision based on Annual Disclosure/ *Self-Declaration Report submitted by the medical college for year 2024 and has taken following decision:*
